Case Study: Roster and Shift Setting in CPAnywhere

案例研究：CPAnywhere 中的更表和輪班設定

Proper use of roster and shift setting in CPAnywhere will help HR people to better manage staff scheduling, especially when unusual situation occurred that require adjustment to the normal work schedule.

正確使用 CPAnywhere 中的更表和輪班設定將有助於 HR 人員更好地管理員工值班安排，尤其是當發生需要調整正常工作安排的異常情況時。

Assuming that Ricky is in charge of a professional firm's IT administration. He has to set up the roster patterns in order to apply to each employee. The system works perfectly well in normal situations. What happens when he needs to make the amendment to more than one roster pattern? He would then need to go back and forth of each affected pattern in order to see the whole picture. To solve this common situation, we have devised a new way of better managing the amendment.

To make multiple amendments, Ricky just needs to first select the month, and then select all the affected rosters. We use rosters A and B as the examples. The system will display the colored-coded shifts for ease of visual scan that makes the changes a lot easier.

We are pleased to announce that we have added the “Enforcement List” of the Securities and Futures Commission (“SFC”) to our growing lists of individual and entity checks. As of today, AML for CSA is able to perform the following solid functions:

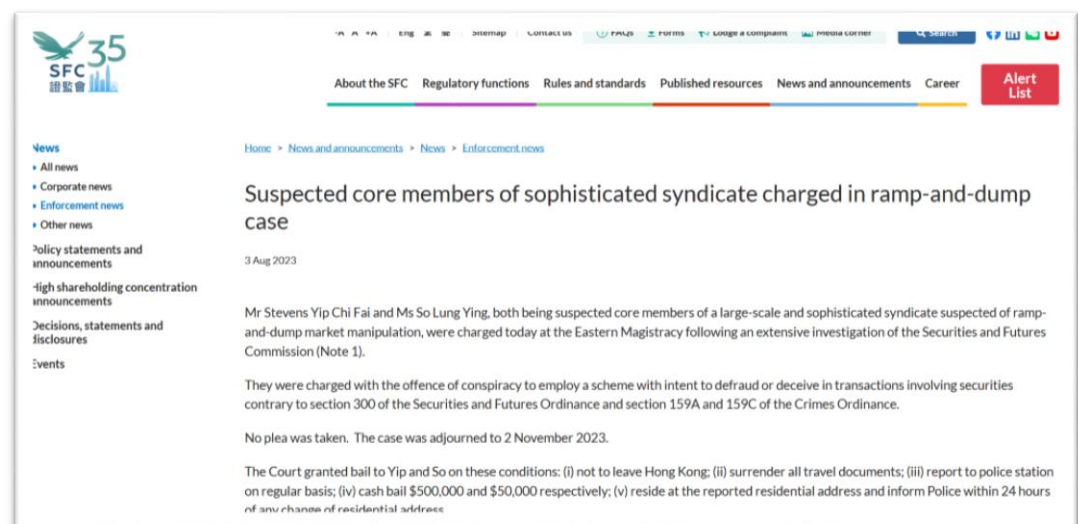

USA Green Card: Pros and Cons

The US is broke. She desperately needs money. There are usually three ways to get her money. The first way to earn money is to export more than import and that has been proven not working. The second way is to print money which she has been doing. The third way is to increase taxes and that proved to be suicidal. So, what's left? When a man is broke, all he can think of is to collect the old debts. In this case, the old debts mean the past taxes and penalties from non-filers.

Last year, the Inflation Reduction Act funded the new hire of 87,000 IRS agents, some carry guns, with the hope of raising additional revenue. The agency will look at various areas. One area is foreign green card holders who have been in low compliance. If you have complied with the US tax and foreign bank requirements, you know how complicated and time-consuming it is even if you have no reportable income.

This sudden increase in law enforcement has placed many foreign green card holders in disarray, especially the ones that are not in full compliance with the tax and foreign bank reporting.

If you are holding a US green card, you will incur the following liabilities:

- (1) Worldwide income tax
- (2) Estate and gift tax
- (3) Foreign bank reporting
- (4) Foreign financial assets reporting
- (5) Foreign-holding corporation reporting.

Normally, the Statute of Limitation is three years if you have filed the correct forms. That means the agency cannot audit you for any period before the beginning of the three years. If no report is filed, then there is no limitation. That is why the first thing tax auditors would do is ask you to sign a Waiver of Statute of Limitation so that they can conduct the audit without the fear of losing out on the tax period. If you refuse to sign the Waiver, they will then just do a rough estimate and send you the bill for payment. This is considered the most important thing that a tax auditor needs to do before even doing anything else.

Now, let us consider the benefits. Holding a US green card allows you to stay in the US permanently unless you are using the Investment Scheme or the "Married to US Person"

status. However, this is not entirely true. If you left the US for more than six months, you need to justify to the US immigration officer that your leaving is temporary only. Many green card holders get warnings if the period of staying outside the US is long, which means over six months. If the officer considers that your presence in the US is temporary in nature, he may confiscate your green card and then ask you to appear before an immigration judge to explain your situation. What I am trying to say is that holding a green card doesn't automatically allow you to come back to the US at will.

To get rid of those US tax and foreign bank requirements, you do need to go to the US embassy to fill out a declaration of giving up the permanent residency and return the green card. Afterward, you still need to file Form 8854 to complete your final expatriation process.

In conclusion, it is always better to stay away from the US tax net in a legal way rather than live in fear that you or your estate may someday be the target of tax enforcement.
